**ORDER**

Upon the application of Mr Attorney S Sookia, appearing for the applicant and after considering the proceipe and affidavit, both dated 13<sup>th</sup> of June 2025 and the documents filed in support thereof, I order that an interim order in the nature of an injunction be issued:

- (i) restraining and prohibiting the Respondents from proceeding with the e-voting for the reconstitution of the Board of Directors of the African Network Information Centre (AfrinIC) Ltd which will be held on 16 June 2025;
- (ii) restraining and prohibiting the Respondents from proceeding with the election for the reconstitution of the Board of Directors of the African Network Information Centre (AfrinIC) Ltd which will be held on 23 June 2025;
- (iii) directing and ordering the Respondents to proceed with the election for the reconstitution of the Board of Directors of the African Network Information Centre (AfrinIC) Ltd according to the ByLaws of the Respondent No. 1; and
- (iv) directing and ordering the Respondents to proceed with the election for the reconstitution of the Board of Directors of the African Network Information Centre (AfrinIC) Ltd according to the Court's Order delivered in case bearing SC/COM/MOT/000156/2023 by the Supreme Court of Mauritius (Commercial/Bankruptcy Division) on 12 September 2023.

The above interim order to remain in force until the determination of the present matter and I order that service be effected upon the above-named respondents to show cause, if any, why the present interim order should not be made interlocutory pending the determination of the main case to be entered by the applicant.

The above interim order in the nature of an injunction is issued at applicant's own risks and perils, and upon its undertaking, through its Attorney to abide by any Order which the Court or Judge may thereafter make as to damages to the respondents by the granting of this interim order in the nature of an injunction.

The respondents are hereby requested to communicate their stand on the **e-filing system** on or before **30<sup>th</sup> of June 2025**, date on which the present matter is made returnable.
